The Looking UP project: target and main objectives

TARGET:

- Organisations, informal groups, cooperatives.... especially the small ones, that work in the field of urban and rural local development in the framework of ecological transition and social solidarity economy → they play a key role in the development of their communities but often don't know of the policies and strategies that guide local urban/rural development at European and national level and often they don't have the opportunity to know what happens in similar realities in other place of Europe
- People, students, teachers.... Everyone wants to approach these topics from a transnational perspective

OBJECTIVES:

- Enhance their knowledge, awareness and civic engagement on the topics of urban and rural <u>local development</u> in the framework of <u>ecological transition</u>, <u>social solidarity economy</u> and the policies that at different levels guide these actions
- Strengthening those organizations and bringing them closer to the European dimension by making them subjects of an exchange, enhancing their know-how and their networks

The Looking UP project: approach and results

APPROACH:

- Bottom-up approach, funded on active listening to the participants' training needs (Co-designed training)
- Peer-to-peer logic, building, as most as we can, a learning community.
- Practices as case studies: fostering a peer-to-peer exchange and an in-depth analysis of different realities chosen as case studies
- Common collection of policies and strategies at national and european level

• 1 Toolkit: materials, case studies, tools collected regarding sustainable participatory local development, SSE and ecological transition, policy lines of national and EU actions (4 LANGUAGES)

-From OXFAM Report 2024-


During the last 10 years, global poverty has increased by 60%. (OXFAM 2024)

SOCIAL SOLIDARITY ECONOMY

Social Solidarity Economy is a way to satisfy human needs and rights through social, cultural, economic activities that reinforce values of social justice, ecological sustainability, cooperation, mutuality, community and democracy.

It is expressed by a constellation of grassroots groups, civic organizations, consumers and producer-based platforms, cooperative and social enterprises, and collaborative public institutions.

The Social Solidarity Economy proposes a system that is not only economic, but also sociopolitical and cultural, basing life-sustaining processes at the centre of socio-economic activity, placing people, communities and the environment above capital and its accumulation, and rejecting relations of inequality and exclusion based on gender, sexual orientation and identity, age or origin through values related, among others, to cooperation, reciprocity, self-management and solidarity.


- At its 66th plenary meeting on April 18, 2023, the United Nations General Assembly adopted the resolution:



PARTICIPATORY LOCAL DEVELOPMENT

• Community development

Founded on a place-based approach \rightarrow not as a simple decentralisation of globalised development, but deeply anchored in context and communities

- Participatory approach to be a real liberation process.
- Has to be aim to enhance individuals and territories
- Has to be sustainable

Recognised in the framework of European policies from the **EEC Treaty of Rome (1957)**, to regional territorial cohesion policies (Regional Development Fund, 1973), to Article 174 of the Treaty on the Functioning of the EU (1992-

2007).
